- For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve Price by way of RTGS/NEFT/Fund Transfer to the credit of account number 7663500300002401, Karnataka Bank Ltd, Tirupur PN Road Branch, IFSC code KARB0000766 or by DD/pay order favouring "Karnataka Bank Ltd., A/c- M/s.Body Glove Apparel", payable at Tirupur.
- 2.
