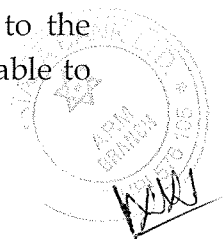

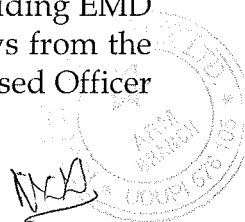

- 3) The bid will be open to bidders and an opportunity will be given to enhance the bid amount in the multiples of Rs. 25,000/- the incremental bid amount mentioned overleaf. Inter-se bidding among the qualified bidders shall start from the highest bid quoted by the qualified bidders. During the process of bidding, there will be unlimited extension of "05 minutes" from the end time of E-auction shall be automatically extended by 05 minutes, each time if last inter-se bid is made within 05 minutes from the last extension. 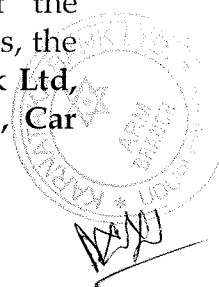


12) All bidders who submitted the bids, shall be deemed to have read and understood the terms and condition of E-auction sale and be bound by them.
