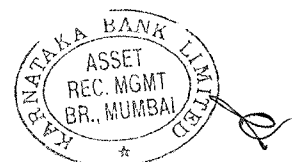

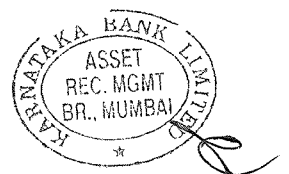
TERMS AND CONDITIONS OF SALE

Ltd.".
- 2) After Online Registration, the intending bidder should submit the duly filled in bid form (format available in the above website <https://www.auctionbazaar.com/>) along




with DD/quoting the UTR number or NEFT RTGS remittance towards EMD in a sealed cover as "Tender/Bid for property purchase pertaining to A/c - M/s Green Vege Exports Pvt.
