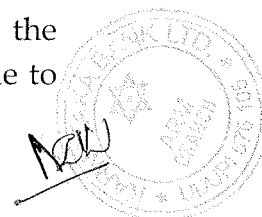

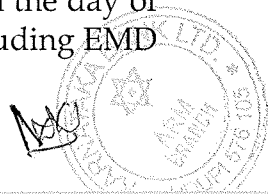
TERMS AND CONDITIONS OF SALE:

1) For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve price by way of RTGS/NEFT/fund transfer to the credit of account number 5803500200004101, Karnataka Bank Ltd, Mavinakatte-Kenchanoor Branch, IFSC code KARB0000580 or by DD/Pay Order favouring "Karnataka Bank Ltd., A/c Mrs. Amina Bibi", EMD of unsuccessful bidders will be returned.

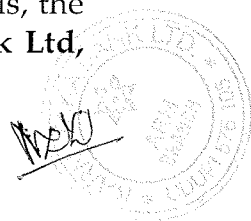

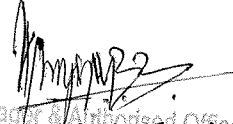
12) All bidders who submitted the bids, shall be deemed to have read and understood the terms and condition of E-auction sale and be bound by them.
