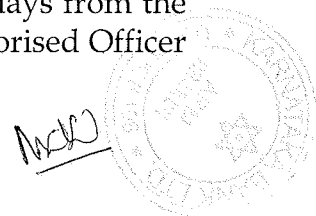
TERMS AND CONDITIONS OF SALE:

1) For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve price by way of RTGS/NEFT/fund transfer to the credit of account number **4573500200004101**, **Karnataka Bank Ltd, Kannarpady -Kadekar Branch, IFSC code KARB0000457** or by DD/Pay Order favouring "Karnataka Bank Ltd., A/c Mr. Mansoor" EMD of unsuccessful bidders will be returned.



- 5) Successful Bidder/Tenderer shall submit self-attested copy of Photo Identity Proof and PAN card, as acceptable to the Bank before 'Confirmation of Sale'.
