
TERMS AND CONDITIONS OF SALE:

- 1) For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve price by way of RTGS/NEFT/fund transfer to the credit of account number 6103500200004101, Karnataka Bank Ltd, Padubidri Branch, IFSC code KARB0000610 or by DD/Pay Order favouring "Karnataka Bank Ltd., A/c Mr. Narasimha Shetty". EMD of unsuccessful bidders will be returned.
