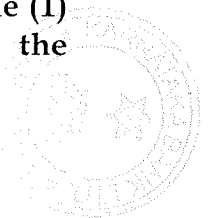

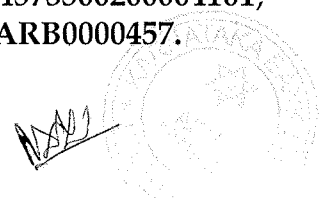

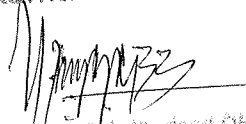
TERMS AND CONDITIONS OF SALE:

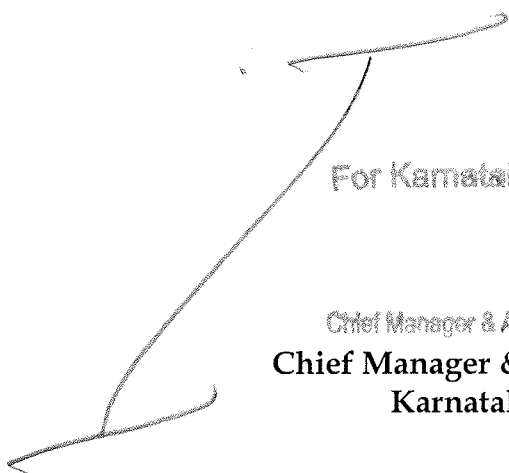
