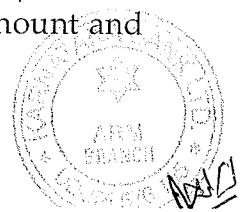
#### **TERMS AND CONDITIONS OF SALE:**


