- 1) Tenders in Sealed covers addressed to the Authorized Officer should be accompanied with EMD deposit like DD/UTR number along with Request letter for participation in the e-Auction, by duly filled in bid form (format available in the above website [www.auctionbazaar.com](http://www.auctionbazaar.com)) along with self-attested copies of (i) Proof of identification (KYC) Viz ID card/Driving License/Passport etc., (ii) Current Address -proof of communication, (iii) PAN card of the bidder (iv) Valid email ID (v) Contact number (mobile/Land line of the bidder etc.,) to the Authorized Officer, **Karnataka Bank Ltd., Indi Branch GROUND FLOOR, PLOT NO:11, SHANTESWARA BUILDING, OPPOSITE I.B., Vijayapura ROAD, INDI Vijayapura District Karnataka - 586209** . on or before 5.00 P.M on **29-08-2025**.
- 2) In case of joint bidders, an authorization letter signed by all the bidders authorizing actual bidder (one among them) to submit and participate in the bid on their behalf should be attached to the bid form. Similarly, in case the bidder is a company/LLP, a copy of the resolution passed by the Board of Directors authorizing the actual bidder, who is holding a valid Digital Signature, to submit and participate in the bid on its behalf should be attached. - 5) The e-Auction/bidding of the above property would be conducted exactly on the scheduled Date & Time by way of inter-se bidding amongst the bidders, and an opportunity will be given to enhance the bid amount in the multiples of **Rs.10,000/-**. Inter se bidding among the qualified bidders shall start from the highest bid quoted by the qualified bidders.
